Section 2. Instructions to Consultants and Data Sheet

A. General Provisions

1. Definitions

- (a) "Affiliate(s)" means an individual or an entity that directly or indirectly controls, is controlled by, or is under common control with the Consultant.
- (b) "Applicable Guidelines" means the policies of the ACBF governing the selection and Contract award process as set forth in this RFP.
- (c) "Applicable Law" means the laws and any other instruments having the force of law in the Client's country, or in such other country as may be specified in the Data Sheet, as they may be issued and in force from time to time.
- (e) "Client" means the implementing agency that signs the Contract for the Services with the selected Consultant.
- (f)"Consultant" means a legally established professional consulting firm or an entity that may provide or provides the Services to the Client under the Contract.
- (g) "Contract" means a legally binding written agreement signed between the Client and the Consultant and includes all the attached documents listed in its Clause 1 (the General Conditions of Contract (GCC), the Special Conditions of Contract (SCC), and the Appendices).
- (h) "Data Sheet" means an integral part of the Instructions to Consultants (ITC) Section 2 that is used to reflect specific country and assignment conditions to supplement, but not to over-write, the provisions of the ITC.
- (i) "Day" means a calendar day.
- (k) "Experts" means, collectively, Key Experts, Non-Key Experts, or any other personnel of the Consultant, Subconsultant or Joint Venture member(s).
- (I) "Government" means the government of the Client's country.
- (m) "Joint Venture (JV)" means an association with or without a legal personality distinct from that of its members, of more than one Consultant where one member has the authority to conduct all business for and on behalf of any and all the members of the JV, and where the members of the JV are jointly and severally liable to the Client for the performance of the Contract.

- (n) "Key Expert(s)" means an individual professional whose skills, qualifications, knowledge and experience are critical to the performance of the Services under the Contract and whose CV is taken into account in the technical evaluation of the Consultant's proposal.
- (o) "ITC" (this Section 2 of the RFP) means the Instructions to Consultants that provides the shortlisted Consultants with all information needed to prepare their Proposals.
- (p) "LOI" (this Section 1 of the RFP) means the Letter of Invitation being sent by the Client to the shortlisted Consultants.
- (q) "Non-Key Expert(s)" means an individual professional provided by the Consultant or its Sub-consultant and who is assigned to perform the Services or any part thereof under the Contract and whose CVs are not evaluated individually.
- (r) "Proposal" means the Technical Proposal and the Financial Proposal of the Consultant.
- (s) "RFP" means the Request for Proposals to be prepared by the Client for the selection of Consultants based on the SRFP.
- (t) "SRFP" means the Standard Request for Proposals, which must be used by the Client as the basis for the preparation of the RFP.
- (u) "Services" means the work to be performed by the Consultant pursuant to the Contract.
- (v) "Sub-consultant" means an entity to whom the Consultant intends to subcontract any part of the Services while remaining responsible to the Client during the performance of the Contract.
- (w) "TORs" (this Section 7 of the RFP) means the Terms of Reference that explain the objectives, scope of work, activities, and tasks to be performed, respective responsibilities of the Client and the Consultant, and expected results and deliverables of the assignment.

2. Introduction

- 2.1 The Client named in the Data Sheet intends to select a Consultant from those listed in the Letter of Invitation, in accordance with the method of selection specified in the Data Sheet.
- 2.2 The shortlisted Consultants are invited to submit a Technical Proposal and a Financial Proposal, or a Technical Proposal only, as specified in the Data Sheet, for consulting services required for the assignment named in the Data Sheet. The Proposal will be the basis for negotiating and ultimately signing the Contract with the selected Consultant.
- 2.3 The Consultants should familiarize themselves with the local conditions and take them into account in preparing their Proposals, including attending a pre-proposal conference if one is specified in the Data Sheet. Attending any such pre-proposal conference is optional and is at the Consultants' expense.
- 2.4 The Client will timely provide, at no cost to the Consultants, the inputs, relevant project data, and reports required for the preparation of the Consultant's Proposal as specified in the Data Sheet.

3. Conflict Interest

- of 3.1 The Consultant is required to provide professional, objective, and impartial advice, at all times holding the Client's interests paramount, strictly avoiding conflicts with other assignments or its own corporate interests, and acting without any consideration for future work.
 - 3.2 The Consultant has an obligation to disclose to the Client any situation of actual or potential conflict that impacts its capacity to serve the best interest of its Client. Failure to disclose such situations may lead to the disqualification of the Consultant or the termination of its Contract and/or sanctions by the ACBF.
 - 3.2.1 Without limitation on the generality of the foregoing, and unless stated otherwise in the Data Sheet, the Consultant shall not be hired under the circumstances set forth below:

a. Conflicting activities	(i)	Conflict between consulting activities and procurement of goods, works or non-consulting services: a firm that has been engaged by the Client to provide goods, works, or non-consulting services for a project, or any of its Affiliates, shall be disqualified from providing consulting services resulting from or directly related to those goods, works, or non-consulting services. Conversely, a firm hired to provide consulting services for the preparation or implementation of a project, or any of its Affiliates, shall be disqualified from subsequently providing goods or works or non-consulting services resulting from or directly related to the consulting services for such preparation or implementation.
b. Conflicting assignments	(ii)	Conflict among consulting assignments: a Consultant (including its Experts and Sub-consultants) or any of its Affiliates shall not be hired for any assignment that, by its nature, may be in conflict with another assignment of the Consultant for the same or for another Client.
c. Conflicting relationships	(iii)	Relationship with the Client's staff: a Consultant (including its Experts and Sub-consultants) that has a close business or family relationship with a professional staff of the Borrower (or of the Client, or of implementing agency, or of a recipient of a part of the ACBF's financing) who are directly or indirectly involved in any part of (i) the preparation of the Terms of Reference for the assignment, (ii) the selection process for the Contract, or (iii) the supervision of the Contract, may not be awarded a Contract, unless the conflict stemming from this relationship has been resolved in a manner acceptable to the ACBF throughout the selection process and the execution of the Contract.

4. Unfair Competitive Advantage

4.1 Fairness and transparency in the selection process require that the Consultants or their Affiliates competing for a specific assignment do not derive a competitive advantage from having provided consulting services related to the assignment in question. To that end, the Client shall indicate in the Data Sheet and make available to all shortlisted Consultants together with this RFP all information that would in that respect give such Consultant any unfair competitive advantage over competing Consultants.

5. Corrupt and Fraudulent Practices

5.1 The ACBF requires compliance with its policy in regard to corrupt and fraudulent practices as set forth in Section 6.

5.2 In further pursuance of this policy, Consultant shall permit and shall cause its agents, Experts, Sub-consultants, sub-contractors, services providers, or suppliers to permit the ACBF to inspect all accounts, records, and other documents relating to the submission of the Proposal and contract performance (in case of an award), and to have them audited by auditors appointed by the ACBF.

6. Eligibility

6.1 The ACBF permits consultants (individuals and firms, including Joint Ventures and their individual members) from all countries to offer consulting services for ACBF-financed projects.

6.2 Furthermore, it is the Consultant's responsibility to ensure that its Experts, joint venture members, Sub-consultants, agents (declared or not), sub-contractors, service providers, suppliers and/or their employees meet the eligibility requirements as established by the ACBF in the Applicable Guidelines.

6.3 As an exception to the foregoing Clauses 6.1 and 6.2 above:

a. Sanctions	(i) A firm or an individual sanctioned by the ACBF in accordance with the above Clause 5.1 or in accordance with "Anti-Corruption Guidelines" shall be ineligible to be awarded a ACBF-financed contract, or to benefit from a ACBF-financed contract, financially or otherwise, during such period of time as the ACBF shall determine. The list of debarred firms and individuals is available at the electronic address specified in the Data Sheet.	
b. Prohibitions	(i) Firms and individuals of a country or goods manufactured in a country may be ineligible if so indicated in Section 5 (Eligible Countries) and:	
	 (a) as a matter of law or official regulations, the Borrower's country prohibits commercial relations with that country, provided that the ACBF is satisfied that such exclusion does not preclude effective competition for the provision of Services required; or (b) by an act of compliance with a decision of the United Nations Security Council taken under Chapter VII of the Charter of the United Nations, the Borrower's Country prohibits any import of goods from that country or any payments to any country, person, or entity in that country. 	

c. Restrictions for Governmentowned Enterprises (i) Government-owned enterprises or institutions in the Borrower's country shall be eligible only if they can establish that they (a) are legally and financially autonomous, (b) operate under commercial law, and (c) that they are not dependent agencies of the Client

To establish eligibility, the government-owned enterprise or institution should provide all relevant documents (including its charter) sufficient to demonstrate that it is a legal entity separate from the government; it does not currently receive any substantial subsidies or budget support; it is not obligated to pass on its surplus to the government; it can acquire rights and liabilities, borrow funds, and can be liable for repayment of debts and be declared bankrupt; and it is not competing for a contract to be awarded by the government department or agency which, under the applicable laws or regulations, is its reporting or supervisory authority or has the ability to exercise influence or control over it.

- d. Restrictions for public employees
- (i) Government officials and civil servants of the Borrower's country are not eligible to be included as Experts in the Consultant's Proposal unless such engagement does not conflict with any employment or other laws, regulations, or policies of the Borrower's country, and they
- (ii) are on leave of absence without pay, or have resigned or retired;
- (iii) are not being hired by the same agency they were working for before going on leave of absence without pay, resigning, or retiring

(in case of resignation or retirement, for a period of at least 6 (six) months, or the period established by statutory provisions applying to civil servants or government employees in the Borrower's country, whichever is longer. Experts who are employed by the government-owned universities, educational or research institutions are not eligible unless they have been full time employees of their institutions for a year or more prior to being included in Consultant's Proposal.; and

(iv) their hiring would not create a conflict of interest.

7.	General Considerations	7.1 In preparing the Proposal, the Consultant is expected to examine the RFP in detail. Material deficiencies in providing the information requested in the RFP may result in rejection of the Proposal.	
8.	Cost of Preparation of Proposal	8.1 The Consultant shall bear all costs associated with the preparation and submission of its Proposal, and the Client shall not be responsible or liable for those costs, regardless of the conduct or outcome of the selection process. The Client is not bound to accept any proposal and reserves the right to annul the selection process at any time prior to the Contract award, without thereby incurring any liability to the Consultant.	
9.	Language	9.1 The Proposal, as well as all correspondence and documents relating to the Proposal exchanged between the Consultant and the Client, shall be written in the language(s) specified in the Data Sheet.	
10.	Documents Comprising the Proposal	10.1 The Proposal shall comprise the documents and forms listed in the Data Sheet. 10.2 If specified in the Data Sheet, the Consultant shall include a statement of an undertaking of the Consultant to observe, in competing for and executing a contract, the Client country's laws against fraud and corruption (including bribery). 10.3 The Consultant shall furnish information on commissions, gratuities, and fees, if any, paid or to be paid to agents or any other party relating to this Proposal and, if awarded, Contract execution, as requested in the Financial Proposal submission form (Section 4).	
11.	Only One Proposal	11.1 The Consultant (including the individual members of any Joint Venture) shall submit only one Proposal, either in its own name or as part of a Joint Venture in another Proposal. If a Consultant, including any Joint Venture member, submits or participates in more than one proposal, all such proposals shall be disqualified and rejected. This does not, however, preclude a Sub-consultant, or the Consultant's staff from participating as Key Experts and Non-Key Experts in more	

	than one Proposal when circumstances justify and if stated in the Data Sheet.
12. Proposal Validity	12.1 The Data Sheet indicates the period during which the Consultant's Proposal must remain valid after the Proposal submission deadline. 12.2 During this period, the Consultant shall maintain its original Proposal without any change, including the availability of the Key Experts, the proposed rates and the total price. 12.3 If it is established that any Key Expert nominated in the Consultant's Proposal was not available at the time of Proposal submission or was included in the Proposal without his/her confirmation, such Proposal shall be disqualified and rejected for further evaluation and may be subject to sanctions in accordance with Clause 5 of this ITC.
a. Extension of Validity Period	(i)The Client will make its best effort to complete the negotiations within the proposal's validity period. However, should the need arise, the Client may request, in writing, all Consultants who submitted Proposals prior to the submission deadline to extend the Proposals' validity. (ii) If the Consultant agrees to extend the validity of its Proposal, it shall be done without any change in the original Proposal and with the confirmation of the availability of the Key Experts. (iii) The Consultant has the right to refuse to extend the validity of its Proposal in which case such Proposal will not be further evaluated.
b. Substitution of Key Experts at Validity Extension	(i) If any of the Key Experts become unavailable for the extended validity period, the Consultant shall provide a written adequate justification and evidence satisfactory to the Client together with the substitution request. In such case, a replacement Key Expert shall have equal or better qualifications and experience than those of the originally proposed Key Expert. The technical evaluation score, however, will remain to be based on the evaluation of the CV of the original Key Expert. (ii) If the Consultant fails to provide a replacement Key Expert with equal or better qualifications, or if the provided reasons for the replacement or justification are unacceptable to the Client, such Proposal will be rejected with the prior ACBF's no objection.

C.	Sub-
Contracting	

(i) The Consultant shall not subcontract the whole of the Services.

13. Clarification and Amendment of RFP

13.1 The Consultant may request a clarification of any part of the RFP during the period indicated in the Data Sheet before the Proposals' submission deadline. Any request for clarification must be sent in writing, or by standard electronic means, to the Client's address indicated in the Data Sheet. The Client will respond in writing, or by standard electronic means, and will send written copies of the response (including an explanation of the query but without identifying its source) to all shortlisted Consultants. Should the Client deem it necessary to amend the RFP as a result of a clarification, it shall do so following the procedure described below:

13.1.1 At any time before the proposal submission deadline, the Client may amend the RFP by issuing an amendment in writing or by standard electronic means. The amendment shall be sent to all shortlisted Consultants and will be binding on them. The shortlisted Consultants shall acknowledge receipt of all amendments in writing.

13.1.2 If the amendment is substantial, the Client may extend the proposal submission deadline to give the shortlisted Consultants reasonable time to take an amendment into account in their Proposals.

13.2 The Consultant may submit a modified Proposal or a modification to any part of it at any time prior to the proposal submission deadline. No modifications to the Technical or Financial Proposal shall be accepted after the deadline.

14. Preparation of Proposals –Specific Considerations

14.1 While preparing the Proposal, the Consultant must give particular attention to the following:

14.1.1 If a shortlisted Consultant considers that it may enhance its expertise for the assignment by associating with other consultants in the form of a Joint Venture or as Sub-consultants, it may do so with either (a) non-shortlisted Consultant(s), or (b) shortlisted Consultants if permitted in the Data Sheet. In all such cases a shortlisted Consultant must obtain the written approval of the Client prior to the submission of the Proposal. When associating with non-shortlisted firms in the form of a joint venture or a sub-consultancy, the shortlisted Consultant shall be a lead member. If shortlisted Consultants associate with each other, any of them can be a lead member.

A	Proposal shall not exceed this budget. 15.1 The Technical Proposal shall not include any financial information. A Technical Proposal containing material financial information shall be declared non-responsive. 15.1.1 Consultant shall not propose alternative Key Experts. Only one CV shall be submitted for each Key Expert position. Failure to comply with this requirement will make the Proposal non-responsive. Depending on the nature of the assignment, the Consultant is required to submit a Full Technical Proposal (FTP), or a Simplified Technical Proposal (STP) as indicated in the Data Sheet and using the Standard Forms provided in Section 3 of the RFP.

	14.1.2 The Client may indicate in the Data Sheet the estimated Key Experts' time input (expressed in person-month) or the Client's estimated total cost of the assignment, but not both. This estimate is indicative, and the Proposal shall be based on the Consultant's own estimates for the same. 14.1.2 If stated in the Data Sheet, the Consultant shall include in its Proposal at least the same time input (in the same unit as indicated in the Data Sheet) of Key Experts, failing which the Financial Proposal will be adjusted for the purpose of comparison of proposals and decision for award in accordance with the procedure in the Data Sheet. 14.1.3 For assignments under the Fixed-Budget selection method, the estimated Key Experts' time input is not disclosed. The total available budget, with an indication whether it is inclusive or exclusive of taxes, is given in the Data Sheet, and the Financial

	Non-Key Experts, (b) reimbursable expenses indicated in the Data Sheet.
a. Price Adjustment	(i) For assignments with a duration exceeding 18 months, a price adjustment provision for foreign and/or local inflation for remuneration rates applies if so, stated in the Data Sheet.
b. Taxes	(i) The Consultant and its Sub-consultants and Experts are responsible for meeting all tax liabilities arising out of the Contract unless stated otherwise in the Data Sheet. Information on taxes in the Client's country is provided in the Data Sheet.
c. Currency of Proposal	(i) The Consultant may express the price for its Services in the currency or currencies as stated in the Data Sheet. If indicated in the Data Sheet, the portion of the price representing local cost shall be stated in the national currency.
d. Currency of Payment	(i) Payment under the Contract shall be made in the currency or currencies in which the payment is requested in the Proposal.

C. Submission, Opening and Evaluation

17. Submission, Sealing, and Marking of Proposals

17.1 The Consultant shall submit a signed and complete Proposal comprising the documents and forms in accordance with Clause 10 (Documents Comprising Proposal). The submission can be done electronically by email.

17.2 An authorized representative of the Consultant shall sign the original submission letters in the required format for both the Technical Proposal and, if applicable, the Financial Proposals and shall initial all pages of both. The authorization shall be in the form of a written power of attorney attached to the Technical Proposal.

17.2.1 A Proposal submitted by a Joint Venture shall be signed by all members so as to be legally binding on all members, or by an authorized representative who has a written power of attorney signed by each member's authorized representative.

17.3 Any modifications, revisions, interlineations, erasures, or overwriting shall be valid only if they are signed or initiated by the person signing the Proposal.

17.4 The signed Proposal shall be marked "ORIGINAL", and its copies marked "COPY" as appropriate. The number of copies is indicated in the Data Sheet. All copies shall be made from the signed original. If there are discrepancies between the original and the copies, the original shall prevail.

17.5 The original and all the copies of the Technical Proposal shall be placed inside of a sealed envelope clearly marked "Technical Proposal", "[Name of the Assignment] ", reference number, name and address of the Consultant, and with a warning "Do Not Open until [Insert the Date and the Time of the Technical Proposal Submission DeadLine]."

17.6 Similarly, the original Financial Proposal (if required for the applicable selection method) shall be placed inside of a sealed envelope clearly marked "FINANCIAL PROPOSAL" followed by the name of the assignment, reference number, name and address of the Consultant, and with a warning "Do Not Open With The Technical Proposal."

17.7 The sealed envelopes containing the Technical and Financial Proposals shall be placed into one outer envelope and sealed. This outer envelope shall bear the submission

address, RFP reference number, the name of the assignment, Consultant's name and the address, and shall be clearly marked "Do Not Open Before [insert the time and date of the submission deadline indicated in the Data Sheet]".

17.8 If the envelopes and packages with the Proposal are not sealed and marked as required, the Client will assume no responsibility for the misplacement, loss, or premature opening of the Proposal.

17.9 The Proposal or its modifications must be sent to the address indicated in the Data Sheet and received by the Client no later than the deadline indicated in the Data Sheet, or any extension to this deadline. Any Proposal or its modification received by the Client after the deadline shall be declared late and rejected, and promptly returned unopened.

17.10 From the time the Proposals are opened to the time the Contract is awarded, the Consultant should not contact the Client on any matter related to its Technical and/or Financial Proposal. Information relating to the evaluation of Proposals and award recommendations shall not be disclosed to the Consultants who submitted the Proposals or to any other party not officially concerned with the process, until the publication of the Contract award information.

18. Confidentiality	18.1 Any attempt by shortlisted Consultants or anyone on behalf of the Consultant to influence improperly the Client in the evaluation of the Proposals or Contract award decisions may result in the rejection of its Proposal and may be subject to the application of prevailing ACBF's sanctions procedures. 18.2 Notwithstanding the above provisions, from the time of the Proposals' opening to the time of Contract award publication, if a consultant wishes to contact the Client or the ACBF on any matter related to the selection process, it should do so only in writing.
19. Opening of Technical Proposals	19.1 The Client's evaluation committee shall conduct the opening of the Technical Proposals in the presence of the shortlisted Consultants' authorized representatives who choose to attend (in person, or online if this option is offered in the Data Sheet). The opening date, time and the address are stated in the Data Sheet. 19.2 At the opening of the Technical Proposals the following shall be read out: (i) the name and the country of the Consultant or, in case of a Joint Venture, the name of the Joint Venture, the name of the lead member and the names and the countries of all members; (ii) the presence or absence of a duly sealed envelope with the Financial Proposal; (iii) any modifications to the Proposal submitted prior to proposal submission deadline; and (iv) any other information deemed appropriate or as indicated in the Data Sheet.
20. Proposals Evaluation	20.1 Subject to provision of Clause 15.1 of the ITC, the evaluators of the Technical Proposals shall have no access to the Financial Proposals until the technical evaluation is concluded and the ACBF issues its "no objection", if applicable. 20.2 The Consultant is not permitted to alter or modify its Proposal in any way after the proposal submission deadline except as permitted under Clause 12.7 of this ITC. While evaluating the Proposals, the Client will conduct the evaluation solely on the basis of the submitted Technical and Financial Proposals.

21.	Evaluation of Technical Proposals	21.1 The Client's evaluation committee shall evaluate the Technical Proposals on the basis of their responsiveness to the Terms of Reference and the RFP, applying the evaluation criteria, sub-criteria, and point system specified in the Data Sheet. Each responsive Proposal will be given a technical score. A Proposal shall be rejected at this stage if it does not respond to important aspects of the RFP or if it fails to achieve the minimum technical score indicated in the Data Sheet.
22.	Financial Proposals for QBS	22.1 Following the ranking of the Technical Proposals, when the selection is based on quality only (QBS), the top-ranked Consultant is invited to negotiate the Contract. 22.2 If the Financial Proposals were invited together with the Technical Proposals, only the Financial Proposal of the technically top-ranked Consultant is opened by the Client's evaluation committee. All other Financial Proposals are returned unopened after the Contract negotiations are successfully concluded and the Contract is signed.

23. Public Opening of Financial Proposals (for QCBS, FBS, and LCS methods)

23.1 After the technical evaluation is completed and the ACBF has issued its no objection (if applicable), the Client shall notify those Consultants whose Proposals were considered non-responsive to the RFP and TOR or did not meet the minimum qualifying technical score (and shall provide information relating to the Consultant's overall technical score, as well as scores obtained for each criterion and sub-criterion) that their Financial Proposals will be returned unopened after completing the selection process and Contract signing. The Client shall simultaneously notify in writing those Consultants that have achieved the minimum overall technical score and inform them of the date, time and location for the opening of the Financial Proposals. The opening date should allow the Consultants sufficient time to make arrangements for attending the opening. The Consultant's attendance at the opening of the Financial Proposals (in person, or online if such option is indicated in the Data Sheet) is optional and is at the Consultant's choice.

23.2 The Financial Proposals shall be opened by the Client's evaluation committee in the presence of representatives of those Consultants whose proposals have passed the minimum technical score. At the opening, the names of the Consultants, and the overall technical scores, including the break-down by criterion, shall be read aloud. The Financial Proposals will then be inspected to confirm that they have remained sealed and unopened. These Financial Proposals shall be then opened, and the total prices read aloud and recorded. Copies of the record shall be sent to all Consultants who submitted Proposals and to the ACBF.

24. Correction of Errors

24.1 Activities and items described in the Technical Proposal but not priced in the Financial Proposal, shall be assumed to be included in the prices of other activities or items, and no corrections are made to the Financial Proposal.

a. 30.1 After completing the negotiations the Client shall obtain the ACBF's no objection to the negotiated draft Contract, if applicable; sign the Contract; publish the award information as per the instructions in the Data Sheet; and promptly notify the other shortlisted Consultants.



The active engagement of women, youth and other marginalized and disadvantaged groups assumes a pivotal role in guiding transformative and all-encompassing approaches toward achieving climate justice and nurturing environmentally sustainable initiatives, particularly as Africa endeavors to recover from the COVID-19 pandemic. This regional effort aligns with global goals, notably Sustainable Development Goals (SDGs) 5, 11, and 13, which in totality emphasize the empowerment of women and disadvantaged groups to achieve equitable, effective, and sustainable climate solutions. The participation of women in decision-making processes and their equitable access to resources are indispensable factors in formulating robust and ecologically mindful strategies that resonate with these international objectives. The distinctive viewpoints and contributions offered by women have the potential to yield comprehensive solutions that simultaneously address gender disparities, inclusion and environmental issues, furthering the SDGs. As Africa charts its course towards recovery, the emphasis on women's empowerment not only guarantees equitable representation but unlocks a wealth of innovation and resilience needed to navigate the complex intersection of climate change and public health crises. Ultimately, it is through an inclusive and active involvement of women and youth that Africa can forge a more sustainable and just future for all.

To guide a shift towards sustainable recovery across the African continent, the AU developed the Green Recovery Action Plan (GRAP 2021-2027) which provides a framework for sustainable economic recovery from the pandemic. Development of the AU-GRAP took into consideration the African Union Strategy for Gender Equality and Women's Empowerment (GEWE) which encompasses matters concerning economic empowerment, particularly ensuring that women's voices are amplified, and their concerns are fully addressed through effective implementation of legislation and proper financing of gender equality work. This process also considered other regional protocols to ensure alignment with AU member states' commitments.

The AU Transformative Climate Finance program, which is part of the AU-GRAP, specifically focuses n Five (5) key thematic areas: Climate Finance, Clean Energy, Nature Based Solutions, Sustainable Agriculture and Green and Resilient Cities with a focus on Water. In collaboration with the African Union Commission (AUC), the African Capacity Building Foundation (ACBF), the Global Green Growth Initiative (GGGI) will take an inclusive and gender-responsive approach to help operationalize the GRAP through the 'Transformative Climate Finance Program of The AU GRAP aimed at operationalizing the implementation of the AU-GRAP. The Program will specifically target the challenges exacerbating the marginalization of women and youth, exposing them to exploitation and poverty. Consequently, these challenges hinder their ability to access vital resources and opportunities, limiting their potential to amplify their involvement and contributions to climate justice initiatives. This will be through:

- (1) Strengthening the AUC's ability to implement the AU GRAP = **Outcome 1.**
- (2) Enhancing skills of national and regional policymakers to develop inclusive green growth policies, plans and programs in alignment with their nationally determined contributions and climate change strategies = **Outcome 2**.
- (3) Improving the ability for governments and partners to access climate finance for Africa's green recovery, aimed at initiatives that support women and youth = **Outcome 3**.

The core strategic success of the project, driving Outcomes 1 – Outcome 3, comprises of Five (5) phases, with each successful stage dependent on the other. The expectation of Member States is to be involved and engaged in Outcomes 1-3 and through Phases A – E, below:

- (1) **Phase A** = AU GRAP Engagement with Member States, Diagnostics, Key Performance Indicators (KPI's) and benchmarking
- (2) **Phase B** = Finding and Closing out gaps to meet KPI's with Member States
- (3) **Phase C** = Policy Development, through capacity development and enhancing the skills of national policy makers, in line with Phase B with Member States

- (4) **Phase D** = Craft out the Enabling Environment (safeguarding principles to allow financial and human capital to flow) with various Ministries of the AU Member States
- (5) Phase E = Full Scale Implementation of the Project
- 2. Purpose and Scope of the Assignment
- 2.1 Purpose of the Assignment = Outcome 2, Phase A

The main purpose of this assignment is to initiate the AU Transformative Climate Finance program, which is part of the AU-GRAP, through activating Outcome 2 and Phase A, which specifically deals with focusing on Five (5) key thematic areas: Climate Finance, Clean Energy, Nature Based Solutions, Sustainable Agriculture and Green and Resilient Cities with a focus on Water. During the benchmarking process, a comprehensive diagnostic assessment will be conducted to evaluate the progress of the selected Member States/ Regional Economic Communities (RECs) in terms of policy development to reach predefined KPI levels across the Five (5) key thematic areas. Additionally, the evaluation will assess the extent to which gender-responsive and transformative green growth integration has been achieved, with the overarching goal of enhancing impact with respect to the identified KPI benchmarks. Capacity needs assessments will be conducted, and workshops will be held to address the gaps. In addition, during the diagnostic an assessment of gender gaps across the Five (5) key thematic areas will be conducted, with specific KPI's to be met. Specifically, there will be a deep dive analysis on the gender and climate finance nexus to understand the intersectionality of gender dynamics within climate finance frameworks. This will involve examining how gender considerations influence access to and distribution of climate finance, as well as the impact of climate finance interventions on gender equality and women's empowerment. Finally, the mainstreaming AU GRAP gender framework in the implementation and action plan will take place through the development of an inclusive Gender Responsive Toolbox. The creation of the Toolbox will be based on the foundation laid by member states in their dedicated efforts to address gender-related issues, particularly in climate finance and green recovery. Imperative to note is that the diagnostic study will need to draw upon key AU commitments, such as the Maputo Protocol on Women's Rights in Africa and the AU Strategy for Gender Equality and

Women's Empowerment. These commitments are closely intertwined with the objectives of the green recovery action plan and should be considered in tandem.

2.2 Scope

ACBF is a pan-African capacity-building institution that seeks to develop strategic capacity for economic transformation and sustainable development of Africa. Since its establishment in 1991, the Foundation has catalysed scalable change across the continent by investing in capacity-building initiatives in the public and private sectors and civil society organizations. The Foundation has supported capacity-building interventions in over forty-five (45) African countries, including the generation and dissemination of strategic knowledge products.

ACBF is working on the implementation of the African Union Transformative Climate Finance program, which is part of the AU-GRAP. The program's core objective is to execute the GRAP with utmost efficiency, placing significant emphasis on policy implementation, knowledge enhancement, and capacity-building within the domain of climate finance. The AU GRAP is an all-encompassing strategy crafted to achieve multiple outcomes, including job creation, fostering the advancement of environmentally friendly initiatives to, mitigate greenhouse gas emissions, preserve the natural environment, and bolster resilience in the face of climate change.

Consequently, ACBF is supporting the delivery of the Program's Workstream Outcome 2 that is focused on Capacity Development on the Green Growth Policy. Specifically, ACBF seeks to undertake a gender-responsive capacity needs assessment to identify capacity gaps and needs necessary to implement AU-GRAP priority areas, while ensuring the effective integration of gender equality. The assessment will also focus on enhancing policy frameworks and showcasing states' commitment to advancing the intersection of gender and the environment. The designated actions to be carried out to accomplish this objective include:

The aim of these two activities is to gather a comprehensive understanding of the current green growth landscape and identify key areas for improvement in promoting gender-responsive green growth on the African continent.

It is in this regard that ACBF seeks to engage a consultancy firm to undertake a thorough continent-wide scoping and mapping exercise. The purpose of this exercise is to gather valuable data about the status of gender-responsive green growth, including its level of adoption and integration, the key stakeholders involved, the obstacles related to capacity-building and recommendations on how to address the identified gaps

3. Objectives

The main objectives of this consultancy, across Five (5) key thematic areas: Climate Finance, Clean Energy, Nature Based Solutions, Sustainable Agriculture and Green and Resilient Cities with a focus on Water are as follows:

- (1) Conduct a comprehensive situational analysis, examining the current state, of challenges, gaps, and opportunities within the thematic areas, both before and after the COVID-19 pandemic. This process will involve examining AU GRAP Engagement with selected Member States and RECs, Diagnostics, and benchmarking against outlined Key Performance Indicators (KPI's) and benchmarking. Finding and closing out gaps to meet KPI's with Member States. Special attention should be given to assessing the level of gender-responsive green growth across the continent, ensuring that gender and environment nexus is a cross-cutting theme and is weaved throughout all the identified pillars of intervention= Outcome 2, Phase A Phase E^[1], and Pillars 1-6^[2] = OUTPUT 1.
- (1) Review and analyze the global green growth frameworks and agendas, including research, development, and innovation efforts. Examine existing policy and advocacy programs and projects that are being implemented, with a specific focus on assessing the progress made in advancing the gender-responsive green growth agenda = Outcome 2, Phase A Phase E and Pillars 1-6 = OUTPUT 2.
- (2) Conduct a comprehensive mapping and profiling exercise, including donors, governments, international NGOs, private sector organizations, and CSOs. It is important to distinguish between Africa-based and Africa-led organizations and those operating from outside the continent or led by non-Africans = **Outcome 2**, **Phase A Phase E and Pillars 4 and Pillars 1-6 = OUTPUT 3**.
- (3) Investigate the opportunities and challenges encountered by the green-growth sector, including the global impact of phenomena like COVID-19, the accessibility of finance and investment capital, infrastructure limitations, the costs associated with acquiring and adopting green technologies, policy and regulatory frameworks, and considerations related to gender and inclusion.
- (4) Assess how these factors affect institutions and organizations in Africa in fulfilling their mandate concerning the integration of gender-responsive green growth = Outcome 2, Phase A Phase E and Pillars 1-6 = OUTPUT 4.

- (5) Evaluate and gain insights into the significance of gender and social inclusion within the green-growth ecosystem. Examine how gender and social inclusion considerations inform adoption of strategies in the context of promoting sustainable and inclusive green growth **Outcome 2**, **Phase A Phase E, Pillars 4 and Pillars 1-6 = OUTPUT 5**.
- (6) Provide recommendations on addressing obstacles to capacity-building in the realm of gender-responsive green growth. **Outcome 2, Phase A Phase E, Pillars 1-6 = OUTPUT 6.**

4. Main tasks

The main tasks of the activity include:

- (1) Participation in an inception meeting (virtual) as well as developing and submitting an inception report, clearly articulating the methodology of the exercise.
- (2) Conducting a scoping and mapping exercise. This exercise will be conducted, using a following four-step approach:
