INTRODUCTION

The partnership between the African Capacity Building Foundation (ACBF) and the Republic of Malawi began in 2006 when the former provided capacity building support to the country. The Republic of Malawi then became a member of the ACBF in 2007. Since then, the partnership between the Foundation and the Government of Malawi has grown from strength to strength. To date, the country has been a shareholder and member of the African Capacity Building Foundation for 13 years. The country is represented by its Minister of Finance Economic Planning & Development in the ACBF Board of Governors.

ACBF'S INVESTMENTS IN MALAWI

The Foundation's investment in Malawi, to date, has reached about US\$ 3.66 million. ACBF is proud to have supported human and institutional capacity development in the country. The Foundation has supported national projects in Malawi which include the Malawi Statistical Systems Project (MSSP) and Malawi Public Policy Research and Analysis Project (MPPRAP) as well as key institutions like the National Economic Council (NEC), to mention just a few. With support from the ACBF, the aforementioned national institutions have become more valuable and are playing significant roles in the country's development agenda.

MALAWI'S CONTRIBUTION TO ACBF

The Foundation has benefitted immensely from the African and global political influence of the Malawi Government. The country has since 2007 been contributing to ACBF, and to date has made a cumulative contribution of US\$1.15 million.

With the support of the Government of Malawi, ACBF has been able to leverage resources from the international community to support capacity development across Africa and to achieve significant results in support of the continent's development process. Notably, ACBF has been catalyzing change in Africa by investing in capacity development initiatives in the public and private sectors as well as in Civil Society Organizations; providing technical assistance in implementation of capacity development interventions; generating, managing, and sharing knowledge on best practices in capacity building and development management.

The Foundation has strengthened public policy across Africa, produced highly skilled public sector economists and managers, strengthened institutions of financial accountability, and enhanced the effectiveness of non-state actors. ACBF has also supported the creation of platforms for dialogue on, and coordination in capacity development, supported improvements in trade and regional integration, empowered women and strengthened parliaments.

ANNEX 2: SUCCESS STORIES

1. Enhanced inclusiveness and effective participation of Non-State Actors

The MAKNET, a knowledge network spearheaded by the ACBF (from 2008 to 2012) promoted and supported inclusive engagement and effective participation of non-state actors in the Malawi's development discourse.

The network provided a platform for knowledge sharing and ideas-sourcing on strategic national issues. Further, it promoted the consolidation, advocacy and use evidence-based knowledge for decision making by the key development actors in the country. MAKNET project resulted in mobilization of policy experts, academics, professional associations, public and private sector institutions, and individuals to share and debate contemporary developmental issues. With a membership of over 585 individuals and institutions, MAKNET built a legitimate constituency and a voice that is considered reliable and factual. The network ably held forums to share policy briefs and on-line discussions.

Through implementation of MAKNET, the sharing of best practices across professional associations and practitioners was highly promoted. Despite its closure on the 31^{st of} December 2012, MAKNET left a legacy in the form of an Information Bank established as a knowledge network that still lives a repository policy and research reference materials. During the four years of operation, the project resulted in mobilization of policy experts, academics, professional associations, public and private sector institutions, and individuals to share and debate developmental issues in Malawi. The broad-based policy and development research topics of interest included those focusing on: (1) Urbanization in Malawi (2) Role of Chiefs in development (3) Ways of improving foreign exchange generation, and (4) Research for Development.

Through achievement of one of its respective objectives, "cultivating the culture of wide consultation through broadening access to and utilization of information," the Foundation (ACBF) through MAKNET, supported other national economic-development programs through information supply through government, citizenry, and stakeholder engagement. Contemporary development debates had made a good deal of influencing policy pathways.

To harness global information on development, MAKNET leveraged knowledge between professionals in Malawi and those in Diaspora through electronic discussions and social platforms. The gathered information was made available to policymakers to make inputs into development conceptualization, implementation, and management. Locally, MAKNET harmonized development policy debates in collaboration with other institutions such as the Ministry of Development Planning and Cooperation, the Malawi National Assembly, the Reserve Bank, the National Bank of Malawi, the National Statistics Office, the Council for Non-Governmental Organizations in Malawi, (CONGOMA), the Centre for Social Research, the National Association of Business Women (NABW), the Malawi Chamber of Commerce and Industry, the Economics Association of Malawi (ECAMA) and the Polytechnic as the Secretariat. It was therefore recognized that the concept of knowledge generation, sharing and continuous learning was real at MAKNET. The development policy platform formed an affordable way to debate and discuss development issues virtually from one's office and yet at one's own convenience through embracement of technological modernization.

2. 'Harnessing accountability'1 in Malawi National Statistical System

The ACBF supported three main areas in the National Statistical System in Malawi, namely, statistical advocacy, human resource development and training. This support enabled the National Statistical Office (NSO) to develop a Strategic Plan (2007- 2011) that had given rise to the establishment of the National Statistical System (NSS). Based on internationally approved standards, the NSO in collaboration with several line ministries developed the first ever National Strategy for the Development of Statistics (NSDS) - locally referred to as the National Statistical System Strategic Plan for the period 2008 to 2012. This forms the basis of implementation of activities by the NSS.

The Foundation's support led to the update of Malawi's Statistics Act which enabled the NSO to legitimately coordinate the NSS. The updated Act created a Data Ecosystem that included the needs of Government Ministries; the Academia; Civil Society Organizations; the Media; and the general public. The Foundation support empowered NSO and its partners to advocate for systematic institutional changes at various levels of Government institutions including via taking policy makers on study tours to appreciate institutional set-ups in other countries.
